Our work focusses on innovation, development and service delivery in the areas of Living Learning and Earning; Housing and Homelessness; and Youth Justice. Each year we connect with 30,000 vulnerable young people across Australia through the following activities:

## Living Learning and Earning

Hand Brake Turn

- Values for Life seminars and workshops within primary and secondary schools to 25,000 students, parents and teachers across Australia.
- Hand Brake Turn prevocational automotive training to 80 young people peryear across 2 locations.
- fiXit automotive a social enterprise born out of Hand Brake Turn that offers detailing, servicing and repair of vehicles while providing employment to young people.

## **Housing and Homelessness**

- Inside Out the provision of Out-Of-Home-Care and Targeted Care Packages (TCPs) in partnership with the Victorian Government's Department of Families Fairness and Housing through the Enhanced Lead Tenant/Live In Mentor Program offered to young people living in properties across metropolitan Melbourne.
- STEPS Outreach Service support for young people, children and their families with long term relational and practical support, including advocacy, referral and material aid.

#### POSITION OBJECTIVES

This position exists to:

- Manage, develop, and deliver an effective, quality educational and life skills program that will, in conjunction with CA, create a positive, person-centred experience for young people participating in Hand Brake Turn (Local and Mobile).
- Facilitate the development of confidence and self-esteem in the lives of young people, implementing a strengths-based approach.
- Minimise the risk of young people becoming involved or entrenched in the Youth Justice system and/or reoffending and disengagement from education and training.
- Provide coordination and leadership as part of the Hand Brake Turn team.
- Assist with the service and repair of motor vehicles through the fiXit social enterprise when required.

#### **KEY RESPONSIBILITY AND DUTIES**

1. Coordination and Leadership – oversee day to day activities of the workshop, volunteers and students ensuring that they have a clear understanding of their roles and responsibilities in accordance with position descriptions/placement plans & projects, policies, and procedures. Work as part of a team with other Hand Brake Turn staff at both Hand Brake Turn sites.

#### 2. Training Delivery

- Deliver a course curriculum within a workplace and training environment to assist young people to develop skills.
- Work with the Hand Brake Turn team and others to develop and refine training materials, policy and procedure documents and practice manual.
- Work with General Manager to develop Hand Brake Turn and assess experience of young people.
- Delivery training modules according to training and assessment requirements.
- Keep records of training outcomes and notes for Hand Brake Turn Participants.
- Teach students appropriate tool maintenance skills.
- Undertake evaluations and help lead an ongoing commitment to quality service delivery.
- Continually assess state of tools, machinery and equipment used for Automotive Training Delivery.
- Log required maintenance.

#### 3. Hand Brake Turn Mobile

- Visit schools, colleges or community groups and deliver on site training using the Hand Brake Turn Mobile modules.
- Build relationships with stakeholders to keep delivering and promoting Hand Brake Turn Mobile.

• Work with the Hand Brake Turn team to develop and continue refinement of training materials for Hand Brake Turn Mobile.

### 4. Networking and Program Promotion

- Raise awareness of Hand Brake Turn with key stakeholders including schools, local government, community organisations and industry.
- Work with the Hand Brake Turn Coordinator and the Communications team to market Hand Brake Turn through publications, social media, website and print materials, ensuring consistent branding is achieved.
- Maintain positive relationships with stakeholders to promote the strong reputation of Hand Brake Turn.
- Attend key events including conference, agency meetings and connect with key stakeholders including schools, local government, community organisation and industry.

#### 5. fiXit – Social Enterprise

- Assist repair and service all vehicles as assigned by Social Enterprise Coordinator in a timely manner.
- Assist with the flipping of donated vehicles for sale and/or scrapping.
- Order parts and materials as required documenting all transactions required for business operations.

#### 6. Occupational Health and Safety

- Risk assessments are completed for the training site on a regular basis.
- Risk assessments are completed for each teaching module.
- Action is taken to Avoid, Reduce and Control Risks.
- Risks are reassessed to make sure that controls are accepted as part of work practice.
- All aspects of First Aid are maintained, and safety is a priority.
- Exercise individual responsibility around your own safety, and the safety of others, in line with organisational policies and procedures and relevant state legislation. Ensure accurate documentation accordingly.

#### 7. Other

- Plan, prepare and facilitate site visits and recreational activities.
- Travel and work between Dandenong and Sunshine sites as required.
