# Inside Out - Youth Worker

Concern Australia works in partnership with young people and their families to create positive opportunities and hopeful futures. Our programs provide education, employment, housing, youth justice and homelessness services. We focus on innovative and empowering pathways which build on young people's talents and resilience and support them to reach their goals.

### **Primary Job Purpose**

The Inside Out Youth Worker works alongside young people within the Inside Out program, advocating for and empowering them to have hope for a positive future. The Youth Worker equips young people with life skills and resources to promote independence and assist with the transition into adulthood.

As a representative of the organisation, this role also:

- models Concern Australia's OHS & child safe values and behaviours and holds others accountable to the same standard and
- upholds Concern Australia's relationship and reputation with clients, external stakeholders, and the broader community by conducting themselves in alignment with our values of faith, integrity, respect and belonging.

### Responsibilities

### **Referral and transition**

- Assist with the assessment of young people's accommodation and support needs.
- Attend client care team meetings and contribute to assessment and planning for the young person.
- Facilitate a positive introduction and engagement into the program, building a sense of safety and belonging.

### Case support (Outreach)

- Provide support to young people based on their individual communal, physical, emotional, psychological, and spiritual needs.
- Work in partnership with young people, families, and other professionals to implement individual case plans.
- Provide coaching and guidance to young people in life and living skills.
- Advocate with, and on behalf of, young people to ensure they receive access to resources, support, and facilities.
- Utilise Concern Australia's program frameworks to track progress and outcomes for each young person.
- Develop and implement care plans and support case plans in line with regulatory guidelines.

#### Administration

- Maintain and comply with all reporting requirements including case notes, incident reports and evaluation documentation.
- Record and report critical incidents in accordance with government and regulatory body requirements, guidelines, timelines, procedures, and processes.
- Meet all other administrative and documentation requirements as per program guidelines and within regulatory body frameworks.

Duties beyond the scope of this position description but in line with an incumbent's skills, competencies, and training, may be present from time to time. Reasonable requests for such duties to be discussed and agreed with the manager and executed accordingly.

The role requires regular sitting, driving, and working in isolation and requires occasional manual handling, bending, reaching, walking, and standing.

This role requires some after-hours work, participating in a 24-hour, after-hours roster, shared between the Inside Out team, responding to crisis call/support for young people and Live-In Mentors.

## Inside Out - Youth Worker

- Completion of a tertiary qualification in youth work, social work, social sciences or equivalent in a related field.
- Desired, but not essential: experience working in the out of home care sector.

### **Skills**

- Knowledge of Child Protection out of home care systems, and how to support young people impacted by trauma.
- In-depth knowledge of crisis intervention and case management.
- Highly developed interpersonal rapport and relationship building, especially with young people, while maintaining appropriate professional boundaries.
- Awareness of the requirements of confidentiality and ensure they are respected at all times.
- Excellent written and oral communication, with the ability to adapt styles according to the audience.
- Ability to participate collaboratively and constructively within teams of peers, staff, and other stakeholders, as well as initiative and effective personal judgement when working alone.
- Well organised but able to be flexible and manage competing priorities and deadlines.
- Intermediate computer skills, including the frequent, independent use of Microsoft Outlook, Word, Excel, and the ability to write case notes, reports, and associated documentation.
- Attention to detail, especially with maintaining accuracy of case notes and data.

- Working with Children Check.
- Worker and Carer Exclusion Scheme Check.
