HBT YOUTH EMPOWERMENT PROGRAM

One of the most exciting developments of the year was establishing the HBT Youth Empowerment Program (YEP) on 1st April. Funded by the Commonwealth Attorney General's Department, this builds on our longstanding HBT course.

The aims of the YEP are to provide alternative pathways and break patterns of recidivism. It supports the development of life skills, promotes inclusion, builds community resilience and strengthens family support structures.

We were delighted when the Honourable Mark Dreyfus KC MP visited Hand Brake Turn to

launch the YEP, hear about the work of HBT and meet some of the young people who participated in the design of the program.

Through the YEP we can now offer additional supports to young people aged 14-17 years beyond the HBT course – for up to a year – and on additional days. In the first three months this included supporting young people as they reconnected with school, connected with employment opportunities and diverted from custody. We have worked in partnership with schools to strengthen pathways to employment for young people at risk of disengagement.

HBT in Global Competition!

A significant event during the year was HBT being shortlisted in the Schneider Electric Foundation's 25th Anniversary 'Youth Innovation for a Sustainable Future' global competition. Schneider Electric supplies car charging stations across Australia, and the competition's theme of 'a just energy transition' closely aligns with Concern Australia's inclusive approach of working to ensuring no young person is left behind.

The Pacific round was facilitated on behalf of the Schneider Electric Foundation by Ashoka India, an organisation supporting social entrepreneurs and changemakers. From more than 100 applications, we were selected to present alongside 19 other youth organisations from China, Indonesia, India, Bangladesh, the Philippines, Vietnam and New Zealand to an international panel of jurors.

Alongside our Chair and CEO, representing Concern Australia in the pitch was Faith, a graduate of our HBT and fiXit programs. Faith

is also about to return to the team as a part-time employee while completing her education. Faith spoke eloquently and passionately about the importance of providing holistic support to young people and the value of programs who include everyone, especially young people who have disengaged early or experienced disruption to their education. Once again we were reminded of the power of foregrounding young people's voices and the amazing contribution they make to ensure our services are as impactful as possible.

We were delighted to be part of this process and honoured to be commended for our innovative and valuable work, despite not progressing to the global shortlist.



INSIDE OUT

The Inside Out program provides housing and support to young people aged 15–18 years who are transitioning from state care to independence. In 2024–25 we supported over twenty-five young people through the program. We continue to work closely with Child Protection and other agencies to provide holistic support which prepares young people for adulthood and independent living.

Live-in Mentors

Over 20 volunteers served as live-in mentors during the year, providing positive role models for young people and supporting them with the development of independent living skills.

The Inside Out staff team work closely with mentors to provide holistic support to young people transitioning to independence. This year our mentor training included Alcohol and Other Drugs as well as team building and peer learning opportunities.

Our mentors come from a wide range of professional backgrounds and countries including Australia, Columbia, England, India, Ireland, Philippines, the USA and Zimbabwe. Not only does this create an amazing community of people, mentors often use their own experience of building a life in Melbourne to support young people as they prepare for independence.



Home Stretch Symposium

Concern Australia strongly supports commitments to extend support for care-experienced young people beyond the age of 18. CEO Judith Atkinson and General Manager Andrea Greenwood joined others in the sector at the Home Stretch Conference to explore advocacy, strategies and best practice in this area. Andrea also had the opportunity to catch up with Dylan Langley, an advocate for social change and seeing young people reach their full potential, who was an MC for the event.



Concern Australia part of innovative e-learning initiative with Salvos, Anglicare and eWorks

Concern Australia was part of an innovative e-learning initiative alongside Salvos, Anglicare and eWorks, aimed at developing a micro-learning program for new and emerging leaders in the Community Services sector. Concern Australia was invited to test the program's suitability for small and mid-sized organisations.

Funded by the Dept. of Jobs, Skills, Industry and Regions, the pilot program delivered bite-sized, self-paced online modules designed to upskill capabilities in different areas such as:

1. Transformational Leadership
2. Leading Workplace Culture
3. Collaborative Practice and Partnerships
4. Resource Management

The project responded to an identified need in the sector to support new and emerging leaders already in leadership roles, but who may not have the time or resources to commit to formal qualifications. Concern Australia staff across different roles participated in oversight development, working groups and module testing. Participants found the experience valuable, and the modules were well received by the wider staff group.

Christmas & Holiday Outreach

The Christmas and holiday season is a particularly important time for STEPS. The team provides outreach in the city and beyond at a time when many young people experience isolation and loneliness. This year, the team made more than 35 home visits, undertook street outreach across the city, and distributed over 200 Christmas gifts generously donated by our corporate sponsors.

This was an exciting and busy year for the STEPS team with over 120 people experiencing and moving on from homelessness supported.

We are grateful to our funders who enabled STEPS to provide:

STEPS also provided scholarship help to 10 young people to empower them to stay in school.

The school holidays are a key time for STEPS to support young people as they prepare for the new school year. Education is one of the most important protective factors in preventing young people from experiencing homelessness.

CASE STUDY

From Mentoring to Milestones

When Elijah first volunteered as a STEPS' mentor back in 2017, 'Chris' was just 10 years old. What began as weekly catchups soon became a powerful and lasting connection. Elijah offered Chris more than just someone to talk to—he became a consistent, positive role model through the ups and downs of growing up.

Their time together was filled with laughter and everyday adventures—whether it was bouncing around at trampoline parks, catching the latest movie, shooting hoops, or even braving the occasional much-needed haircut. From long walks with the dog to meals shared over meaningful conversations, Elijah showed up with patience, care, and a listening ear.

Over the next eight years, Elijah walked beside Chris, helping him build confidence, strengthen self-esteem, and believe in his own potential. In 2024, Elijah—alongside Chris's youth worker, Thanh—proudly attended Chris's Year 12 graduation, a powerful moment that marked just

how far Chris had come. Though Elijah has now relocated, he remains in touch and committed to cheering Chris on from afar.

Chris shared that while he's sad to see Elijah go, he's incredibly grateful for the difference Elijah made in his life: "He helped me become more confident, talk to people, and believe I could actually finish school," Chris said. "I don't know where I'd be without him."

The Bernie Gerlinger Hope for the Future Scholarship program is run by STEPS Outreach Service in partnership with the Rotary Club of Central Melbourne.

Elijah Hoe was a volunteer mentor for 'Chris' (name changed), a young person in the Scholarship program from 2017-2025. We are very grateful for Elijah's long-term commitment and care and his heart for making a difference.

HAND BRAKE TURN (HBT)

Over 90 young people undertook our five-week HBT course over the year, the first full year of our updated curriculum and inclusive classroom design.



As a trainer and mentor, it gives me joy to watch young people grow throughout the HBT + YEP. Seeing them discover their strengths, build on their talents, and set achievable goals is truly rewarding.

We all can be inspired by watching their confidence return and the moment they realise they belong, have purpose, and that their future is something to be hopeful about.

That's what makes this journey so powerful.



With the generous support of the **Werkling** (On-Demand Talent) Community, we have begun developing our digital classroom as part of our course delivery.

The donation has enabled the purchase of equipment to move elements of the curriculum online, as well as learning aids to support neurodiverse learning needs. This ensures all young people can more easily participate in lessons and are better prepared to navigate their future workplaces.

Cyber Security Awareness Project



For young people growing up in our increasingly online world – with its fast pace of change – being cyber safe is crucial. We were pleased to receive support from the **Commonwealth Department of Home Affairs** for a three-year project to provide cyber safety workshops to young people in our programs.

It quickly became apparent that young people were the experts on developments in the digital world and so have been increasingly involved in the design and delivery of the workshops. Our ambition for 2026 is for young people to deliver the workshops to our staff and volunteers.

Scanlon Foundation Program

The Scanlon Foundation aspires to see Australia advance as a welcoming, prosperous and cohesive nation particularly related to the transition of migrants into Australian society.



We were delighted when they provided funding to Concern Australia to develop a 'coach and connect' program throughout 2025, providing tailored mentoring support to young people with migrant and refugee experiences to connect with employment pathways.

This support has enabled us to pilot new approaches and opportunities, including the planning and piloting of two young adult pathways in the second half of 2025.

HBT Mobile in the Community

This year, we delivered our automotive workshops in schools, neighbourhood houses, libraries, civic centres and places of worship to over 200 participants.

We partnered with a range of agencies to provide basic automotive education in many settings, including to newly arrived communities, young people transitioning from care, disability organisations and many more.

With the support of local governments and others we helped people better understand their car to ultimately be safer when driving.



fiXit SOCIAL ENTERPRISE

Providing jobs and employment experience

During the year, fiXit **employed eight young people** who had graduated from our HBT course. All went on to employment, further education or training, or a combination of the two.

Young people in the program received wraparound support and mentoring, developed practical skills in automotive work, teamwork, health and safety, workplace rights and responsibilities and much more.

A record number of cars were generously donated by the community to fiXit this year.

fiXit's primary source of revenue is generated through receiving and repurposing donated cars.

The cars we receive are either sold or used as training vehicles for young people as part of the program.

We love that many donors share stories about what their car means to them or their family and how they want to donate it as a way of creating positive futures for young people.

Social Impact Sector Involvement

This has been a year of significant exploration, change and growth for fiXit which has enabled it to mature as a social enterprise.

Financial and advisory support from the Westpac Foundation enabled us to develop our systems and receive many more car donations. We participated with peer organisations in WISE (Work Integrated Social Enterprise)

activities. fiXit was studied as part of the Social Impact Hub's Fellowship Program. We were also thrilled when fiXit received a capacity-building grant from the Commonwealth Government's Social Enterprise Development Initiative program which will be implemented in FY 2026.

SUPPORTER SPOTLIGHT:

William's amazing effort to support the STEPS Outreach Service

STEPS has participated in Run Melbourne for the past 10 years, raising much needed donations which help to keep the program running. This year **among the dedicated participants was an 11-year-old boy with a heart of gold, William, participating for the first time.**

Since he was very young, William has always had a desire to help those less fortunate. Whether it be through food donations to wildlife hospitals, making a lemonade stand to raise money for the local CFA, or, in this case, running to raise funds for the STEPS Outreach Program.

With the help of his parents, William looked up the STEPS website to see how donations help. Seeing that \$30 could provide two days of groceries, \$50 could provide new clothes, and \$100 could provide one night's crisis accommodation he decided his goal was to raise \$100. He phoned family, wrote emails to other family and friends, and reached out to his parents' professional networks explaining why he wanted to raise funds. **He raised \$1,331.**

When he realised his fundraising efforts could support 44 young people with groceries, or 10

people with crisis accommodation, he shouted, "Woah! I can't believe I did that. I'm in shock!"

William lined up at the starting line with other STEPS team members before dashing up Batman Avenue. As he ran past many of Melbourne's famous landmarks, (and yes, he managed to run the whole way!), his focus wasn't on the medal he'd receive as he crossed the finish line. Instead, it was the knowledge that he was making a tangible difference. "Come on Mum, keep going, we're doing this for others, not us!" he shouted to his mum, Kellie, as they hit the 3 km mark. After the race, he returned to meet the STEPS team for high-fives.

STEPS Outreach Service is so thankful to William and all the STEPS Run Melbourne team for their fundraising efforts. The team raised more than \$8,000 which will help to support more young people experiencing homelessness to have positive life outcomes.





TREASURER'S REPORT

As noted in other reports, this has been an exciting year for Concern Australia as we have seen the growth of some of our programs and have been able to undertake valuable additional projects with young people. We are very grateful to our generous donors and supporters who have made this possible.

The 2024-25 Financial Year had a good result which returned Concern Australia Welfare to a surplus position. In addition, we were able to invest in some of our programs and assets to reduce upcoming costs and consolidate for the future. As foreshadowed in last year's Report, the Executive have begun working towards strengthening our underlying financial position and good progress has already been made in this direction.

In consultation with the Fair Work Ombudsman, we have continued to address the historical Industrial Relations corrections (see Annual Report 2023-24 for more details) and we hope to conclude the matter in the 2025-26 Financial Year.

Once again there was less activity under our Ministry entity and as a result the Executive and Board have commenced a strategic consultation and review to determine possible options and the way forward.

I would like to thank those who have provided pro bono support this year, in particular Stephen Sasse with strengthening our industrial relations systems, and automotive industry supporters to our social enterprise business.

As well as meeting regularly as a Board, each of the members provides support to subcommittees, in particular the monthly FRAC (Finance, Risk and Compliance) and Governance committees. I would like to thank them for providing their expertise along with diligence and commitment to maintaining a strong and healthy organisation.





Our HBT Youth Empowerment Program featured in the Dandenong Star
